("Seller") warrants to the original purchaser only, that all CS Unitec electric portable power tools will be free from defects in material or workmanship for a period of one year from date of purchase, all pneumatic and hydraulic portable power tools for a period of six months from date of purchase and tools designed for underwater use for a period of 30 days from date of purchase. SELLER'S SOLE OBLIGATION AND YOUR EXCLUSIVE REMEDY under this Limited Warranty and, to the extent permitted by law, any warranty or condition implied by law, shall be the repair or replacement of parts, without charge, which are defective in material or workmanship and which have not been misused, carelessly handled, or misrepaired by persons other than Seller or Authorized Service Station. To make a claim under this Limited Warranty, you must return the complete portable power tool product, transportation prepaid, to CS Unitec, Inc. or to an Authorized Service Station for evaluation. The one-year and six-months limited warranties do not apply to tools used underwater. Hydraulic and pneumatic tools designed for underwater use are covered by a 30-day limited warranty against defects in material and workmanship. The warranty does not cover misuse or abuse. **NOTE: Only tools designated in writing for use underwater are covered by this warranty. Any tools not designated for underwater use and which are used underwater will void the warranty.**

CAUTION: Electric tools are never for use underwater for safety reasons.

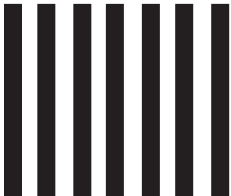
